Change to the definition of "Valuation Day"

Dear Shareholder,

We would like to inform you that the board of directors of Franklin Templeton Investment Funds (the "Company") has decided to amend the definition of the terms "Business Day" and "Valuation Day" in the general part of the prospectus of the Company with effect from January 1st, 2024. The purpose of this amendment is to guarantee an alignment between Dealing Days and Valuation Days, and to avoid possible challenges in meeting subscription and redemption requests when the invested markets may be closed. We therefore expect this amendment to ease shareholders' operativity in the Company.

The terms "Business Day" and "Valuation Day" are currently defined in the section "Definitions" of the general part of the prospectus as follows:

"Business Day"

"Valuation Day" or "Pricing Day"

a day on which the banks in the relevant jurisdiction(s) are normally open for business

any day on which the New York Stock Exchange ("NYSE") is open or any full day on which banks in Luxembourg are open for normal business (other than during a suspension of normal dealing). With respect to the Franklin Japan Fund, Franklin Sealand China A-Shares Fund, Templeton All China Equity Fund and Templeton China A-Shares Fund, the Management Company may also take into account whether relevant local stock exchanges and/or Regulated Markets which are the principal market(s) for a significant portion of the investments attributable to the Franklin Japan Fund, Templeton All China Equity Fund and Templeton China A-Shares Fund are closed for trading, and may elect to treat such closures as non-Valuation Days for these Funds. Further information on the applicable Valuation Days for the Funds can be found on the website: http://www.franklintempleton.lu

As from 1 January 2024, the definition of the terms "Business Day" and "Valuation Day" in the aforementioned section of the prospectus will be amended so as to read as follows:

"Business Day"

a day on which the banks in the relevant jurisdiction(s), as set out in the relevant Fund's specific information sub-section, are normally open for business

"Valuation Day" or "Pricing Day"

Consequently, as from 1 January 2024, the specific sub-section "Valuation Day" for all sub-funds of the Company will be amended as follows:

Amendment of the Franklin Gulf Wealth Bond Fund's investment policy

Dear Shareholder,

We would like to let you know that the board of directors of Franklin Templeton Investment Funds (the "Company") has decided to enhance the investment policy of the Franklin Gulf Wealth Bond Fund (the "Fund") to introduce some new ESG exclusions. In this respect, the following paragraph is added after the second paragraph of the Fund's investment policy:

"The Fund does not invest in companies which, according to the Investment Manager's analysis:

- are involved in the production of controversial weapons (i.e., nuclear weapons, cluster munitions, landmines, biological and/or chemical weapons, depleted uranium weapons, blinding laser weapons, incendiary weapons, and/or non-detectable fragments, or any other indiscriminative type of weaponry);
- derive more than 5% of their revenue from tobacco or tobacco products; or
- generate more than 5% of their revenue from thermal coal extraction."

Impact

The change detailed above will have no material impact on the way the Fund is managed, its portfolio's composition, risk profile or SRI, nor on the fees charged. The new investment policy will be reflected in an updated version of the Prospectus, a copy of which will be available online or at the registered office of the Company.

All other features of the Fund remain the same.
